

Human Aura, Assemblage Point, Field Resonance and Health

Abstract: Human Central Assemblage Energy Channel and Assemblage Point are vortices of energy around which human toroidal energy bio-fields are assembled as a conglomerate of astral, mental and physical compound. When the assemblage point is located at the center of the chest it is nourished by the main energy flows of earth and cosmic energies running through the Central Assemblage Energy Channel. Its proper location at that position is of prime importance for human physical health, emotional and mental wellbeing. The position of the assemblage point can be managed in three ways: manually – using a specially designed quartz crystal, via Electronic Gem Therapy apparatus, where the space resonance of the electron vibration-oscillations in gems and human tissues is used and the Photon Sound Beam device, using the space resonance of vibration-oscillations of fields of two plasma tubes around the center of human chest that leads to proper positioning of the assemblage point. The two devices are tools working in the quantum healing spectrum and their combination with traditional medical science would lead to a good perspective for quick recovering from many difficult medical conditions.

Key words: Central Assemblage Energy Channel, Assemblage Point, Space Resonance of Fields

INTRODUCTION

There may be distinguished four Human Assemblage Points: the **Stationary Assemblage Point (SAP)** [1], the **Moving Assemblage Point (MAP)** [2], the **Great Light Assemblage Point (GLAP)** [2] and the **Energy Cocoon Assemblage Point (ECAP)** [3, 4]. The MAP moves through the meridian system, circulating in a 24 hour cycle, establishing and maintaining biological cycles (circadian biorhythms). The GLAP is situated at the navel and is an indicator of the individual connection to the Source of Life [2]. As the Toltec teachings [3, 4] evidence the ECAP sits on the rear shell of the Human Energy Cocoon where it collects luminous fibres from the Morphogenetic Field of the Universe, assembles them and thus determines the reality one may perceive. “Only a small group of the energy fields inside the cocoon are lit up at any one time by a brilliant point of light located on the surface of the cocoon” [4]. The ECAP and the SAP are closely connected through these luminous fibres of perception. All these Assemblage Points originate from the division of the Umbilical Assemblage Point.

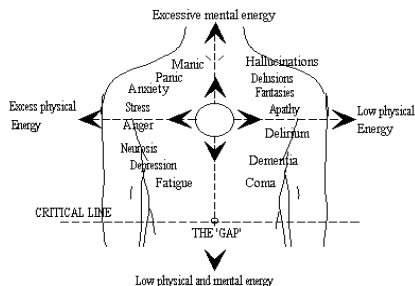


Fig. 1 Dr Whale’s ‘off centre’ map of the approximate SAP locations for various symptoms. The circle on the map indicates the central beneficial for health position and the captions indicate the shifts of the Assemblage Point, connected with the personal conditions and disease.

The **SAP** is the most easily to be established where is located and is the focal point that **governs how everyday reality is perceived**. As Dr Whale’s investigations [5, 6] proved the **Stationary Assemblage Point is the focal vortex of the human energy body. It should be located at (or near) the centre of the chest** but any stress (traumas, violence, intimidation, giving birth, accidents or drug use) can shift it off centre and it can even move into organs like the liver and heart. Each location of the SAP off the centre of the chest – be it left, right, up or down – leads to a certain way of feeling, thinking and medical conditions (Fig.1) [5]. The SAP begins at the navel at birth but **during the first three years of life** it moves up through the Conception Vessel meridian and through the

heart chakra [2]. For the contemporary people the SAP usually becomes situated a little bit in the right chest area that corresponds to the predomination of logical way of thinking.

Human Stationary Assemblage Point may be considered as a perpetually rotating toroidal vortex of energy inside the center of the chest around which the human **perception fields are assembled** as a conglomerate of active physical, emotional and mental attention and awareness. When the assemblage point is located in the center of the chest it is in the **main energy stream** of earth and cosmic energy-information power running through the **Central Assemblage Energy Channel** [7]. **Human Energy Field** (HEF) may be scrutinized as a bio-resonant interference **system of quantum energy-information toroidal layers** wound up around the **Central Assemblage Energy Channel** (Hara Line [8]) and commanded by the up and down energy flows through it. These toroidal layers have different types of frequencies and densities and are forming what is known as etheric, astral, mental, causal bodies etc. The Central Assemblage Energy Channel (CAEC) runs between the first and seventh chakras inside the body and from minus infinity to plus infinity outside it. The 7th chakra channels Cosmic energy, information and consciousness, while the first one connects supplies us with Earth energy-information. All human chakras have the property to curl the entering/exiting through them energy-information flows so to form the energy patterns around the human body that are in the shape of toroids – with the energy flowing through the center of the body and looping around to connect in below the feet and above the head. The **main flow of energy** is through the CAEC and is bidirectional: the “earth” energy enters the first chakra and goes up while the “cosmic” energy enters via the seventh chakra and flows down – both curling to form toroidal patterns with great variety of vibrations. Through the SAP, passes a horizontal energy perception bundle which is of prime importance for our awareness, direction of attention and conscious realization of the surrounding world. Thus these two energy-information flows mix at the center of the human chest. There, the two streams of energies resonating at a wide range of frequencies, curl in two (a vertical and a horizontal) toroids to set up the whole human energy field or human energy cocoon (aura).

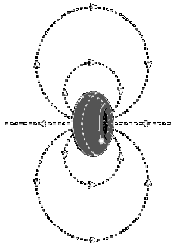


Fig.2. Perpetually rotating toroidal SAP, bio-field lines and perception energy bundle entering between the shoulder blades and going out from the front side of the chest. The field it creates is of the nature of **magnetic vector potential**, induced by the electrical and **energy currents flowing through ventral root of the brachial plexus**. Magnetic vector potential lines of a toroid are of toroidal form! [9]

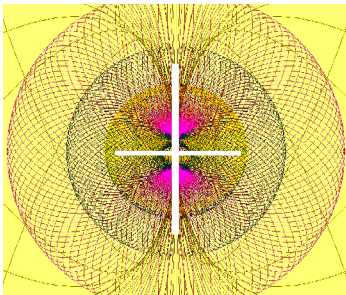


Fig.3 A system of toroidal layers forming the constantly recycling Quantum Scalar and Electromagnetic Fields – Aura, or HEF around any person. Side view of Central Assemblage Energy Channel (the vertical white strip), Energy Perception Bundle (the horizontal white strip) and the Stationary Assemblage Point is at their cross point [7]. The quality of all exchange and flow of energy, also those of the chakras, is determined by the orientation and location of this assemblage point energy bundle – best if horizontal. The front AP energy bundle stands for all the visible result of a person's use of their energy in life. The rear AP energy bundle is the incoming perception energy and primarily tells us about our inner experience and how we actually feel.

The **aim of the work** is to supply some information about two existing trends of medical applications of quantum physics knowledge for management of the SAP location.

Since the two energy information flows (vertical vital and horizontal perceptive) cross at the place where the SAP is (Fig.3), it is clear that the position and the entry/exit angle of the SAP bundle of energy fibers are of crucial importance for the way

we behave and how we feel in our daily life [5]. The key fact for the human being is that these energy flows are organized and function at our subconscious level.

METHODS OF ASSEMBLAGE POINT MANAGEMENT

All elementary particles, atoms and molecules in our bodies vibrate and oscillate thus emitting and absorbing electromagnetic, quantum spherical scalar resonant and torsion waves. As Dr Whale [5, 6] first pointed out the most of the energetic ways of medical diagnosing **are missing the SAP as a conception** and consequently as a possible therapy! Each of the human organs consists of cells with a properly functioning molecular structure, when they are healthy since the electrons are in their normal orbital states. If, for some reason, our tissues are not in their normal states, we become ill. This is due to distortions in the normal energy-information levels of internal and external for the human body quantum energy fields and interactions. Often this leads to unbalanced energy flows through our energy channels. Usually, the main channel that is affected is the **perception energy bundle passing through the SAP**. In many cases the level of impact is so severe that it results in shifting the SAP from its position at the centre of the chest and outside of the nourishing energy flow of the CAEC. Sometimes this may lead to deflection and distortion of CAEC and all the meridian system. Then the electro-chemical balance of the whole organism is violated and recovering becomes quite a complicated process, sometimes impossible with conventional medicine (e.g. multiple sclerosis).

1. Manual shifting of the AP is known from ancient times and was kept for long time as a secret knowledge in some native tribes in America. The existence and the effects of manipulation of the AP on the human energy cocoon first are reported by C. Castaneda [3] in his books.

The manual procedures are described in Dr Whale's books [5, 6]. Using this method the position of the SAP is found manually and can be shifted from its detrimental location by means of suitable quartz crystals by a trained in the technology person. The manual shifting or relocation of the AP to a beneficial position is achieved by the use of properties of large quartz crystals to catch, concentrate inside and then move the perception energy-information bundle at the desired by the therapist and patient location of the SAP. Sometimes more than one shift is necessary – when the initial shift of the SAP is too far from the central position then the relocation of the AP is done step by step.

2. The Electronic Gem Therapy Apparatus. In the cases when patients cannot collaborate the manual shifting of their SAP it is better to use the contemporary electronic vibration-oscillation technologies. The first one to invent and apply devices for the SAP treatment was Dr Whale [5, 6]. First, the position of the SAP may be established manually or by means of Infrared Diagnostic Scanner and then relocated by the electronic gem device. The energy deviations of tissue, organs and glands, as well as AP deflection from its normal location, can be restored to optimum states through application of certain **correcting vibrations-oscillations** of electronic gem therapy [5, 6, 10 & 11]. These are **of the spectrum of visual light** and depending on the necessary treatment, **specific sound frequencies** that activate the electrons and the whole crystal lattices of the gems placed inside the lamps, amplify and transmit healing waves directly into the tissue, organs and glands. Due to inertia of electro-chemical balance of human organism sometimes more than one procedure is necessary to fix the SAP at the centre of the chest.

3. Photon Sound Beam XII shifting of the AP to its central location may be accomplished through the principles of space wave resonance. The two plasma tubes with certain quantum photonic and classical sound vibrations applied at the centre of the chest of the patient quickly and effectively may change the location of SAP from any detrimental position. Since this apparatus [12] works with Tesla coils activating the biological plasma photon emissions from the noble gases, Rife, Abrams and Lakhovsky electromagnetic and sound waves plus a quartz oscillating emitter that is usually placed under the first chakra

of the patient, here we have the possibility to influence directly in a positive way the energy flow through the CAEC. Thus the time duration of the procedure is only one, two or three minutes, depending on the patient. The relocation of the AP is effective and almost immediate, since nourishing the body with harmonically rich frequency carrier waves can re-establish the normal cellular resonance [12].

The case shown in Fig. 3 was of a boy with chronic fatigue since his SAP had dropped 8 cm from its central location vertically below down the CAEC. For the purpose of shifting his AP all frequencies available in the range of the instrument were chosen. The quartz oscillating emitter worked at 25 and 40 MHz with several peak harmonics including the additive compliment of 100 MHz [15].

Photon Sound Beam-instruments [12] provide high quality nourishing plasma electrical energy delivered through glass tube applicators filled with noble gases. They are vehicles for **biological plasma electricity** as well as for Lakhovsky radio wave emissions, photons and subtle quantum energies provided by the plasma emission of the elements. The specific Rife Frequencies allow the action of very low micro-currents to disassociate bound matter and cells. In this way, all the primary (CAEC plus meridians) and subtle energy channels (nadis) are opened-up, so that frequency information and quantum correcting energies may be actually received and integrated by the human body effectively.

CONCLUSION

The latest quantum theories of the electron [13, 14] regard it as a compound of in- and out-going spherical scalar waves that constitute space spherical wave oscillators. By them all the electrons in the Universe accomplish energy-information interconnectedness and exchange, so that the total sum of their amplitudes reaches the minimum value. The interaction between two electrons with different centers is carried out by the space resonance of their spherical waves. If the energies of any of our tissues and organs are heightened, lowered or depleted then their electron states are out of balance. Hence they need reintegration to return to their normal for the human tissues states through creating conditions the minimum amplitude principle [13] to take place for the quantum vibrations of the electrons. Usually in nature, energy is exchanged when two resonances (oscillators) interact with each other. For all oscillator pairs, significant coupling occurs if both have the same or very close resonant frequency. Thus, if one of the oscillators changes its frequency upward, the other changes its frequency downward, i.e. the frequency (= energy) changes are equal and opposite. Hence vibrating with the proper frequency electrons in the crystals can properly correct the gone out of balance energy levels of the electrons in human cells to their healthy states. In this way, the space wave resonance and minimum amplitude principle supplies us with an elegant explanation for the application of electronic vibration technology to treat the unhealthy condition in any tissue or organ using lamp transducers containing gems [5, 6]. Creating a space wave resonance field at the corresponding area by the wave emissions of crystals attracts the SAP from its shifted position to return to its beneficial location for the human being. It was my idea to use the electromagnetic space wave resonance of the two plasma beams of Photon Sound Beam device for proper relocation of human SAP.

What is common in each of the above described technologies is the fact that at any one of them some type of **quantum frequency entrainment** is concerned. The return of

the SAP to its central location creates conditions for **quantum coherence and stability of the human energy body and fields**. Thus our organisms are given the possibility to become ordered by acquiring **compensating 'negative entropy'** from the crystals or the properly chosen frequencies by the apparatuses.

After the application of any of these methods there is almost immediate improvement in the quantum energy fields' strength; people change their posture – their spine becomes straight, the color of the face becomes clear and fresh, the mood turns to positive, heart palpitations disappear etc. Thus, using the resonant space wave entrainment and interference phenomena we may amplify in a positive way the energy-information fields of any human being. As Rakovic [15] points out 'Contemporary investigations of psychosomatic diseases imply the necessity of application of *holistic methods*, oriented to *healing the person as a whole* and not disease as a symptom of disorder of the whole, implying their *macroscopic quantum origin*.' This purpose can be accomplished with minimum efforts by the technology of restoration the central SAP location. This leads to proper **opening of the resonant windows** in frequency and intensity of the human bio-field to the environmental nourishing energies and hence conditions to quick return to health are established.
